Engagement of Hospitals, Individual Practicing Doctors, and Medical Teams for Specialized Health Camps

Kaiserganj Block, Bahraich District, Uttar Pradesh

Sahbhagi Shikshan Kendra (SSK) invites quotations from **registered hospitals, nursing homes, individual practicing doctors, and qualified medical teams** for conducting specialized health camps under the project titled “**Improving Health and Strengthening the Resilience of Vulnerable Groups in Bahraich District, Uttar Pradesh, India**” (Project ID: MI PN 2675-14 | Donor ID: PN 7940).

The project aims to improve **health outcomes, sanitation, nutrition, hygiene, and overall resilience** of vulnerable families across **10 villages of Kaiserganj Block, Bahraich District**.

Scope of Work

As part of the project, SSK plans to organize **specialized health camps in 2026** to address priority community health needs. The proposed **tentative medical specializations** include:

- General Medicine
- Gynecology
- Pediatrics
- Dermatology

The selected service providers will be responsible for delivering **outpatient consultations, basic medical examinations, medication support, and referral services**, as required. Final scheduling and specialization-wise deployment will be confirmed based on **community needs and specialist availability**.

Camp Details

- **Location:** 10 villages in Kaiserganj Block, Bahraich District
(*Revali, Danabal, Sohras, Kandauli, Ghureta, Badrauli, Godaiya No. 3, Chulumba, Godaiya No. 2, and Godaiya No. 4*)
- **Duration:** Health camps to be conducted **once every quarter**, covering all 10 villages
- **Key Focus Areas:**
 - Medical examination and consultation
 - Prescription and distribution of medicines

Required Medical Personnel

Doctors

- MBBS with specialization in the relevant field (General Medicine, Gynecology, Pediatrics, Dermatology)
- Minimum **3–5 years of professional experience**

Nursing Staff

- Certified ANM (**Auxiliary Nurse Midwife**)
- Minimum **3–5 years of experience**

Pharmacist

- **B. Pharma** qualification
- Minimum **3 years of experience**

Interested hospitals, nursing homes, or individual doctors (along with their medical team comprising nurse, compounder, and pharmacist) are requested to submit a detailed quotation including the following:

- 1. Profile of Medical Team**
 - *For Individual Doctors:*
 - Medical registration number
 - CVs of doctor(s), nurse, and pharmacist/compounder
 - *For Hospitals/Nursing Homes:*
 - Valid hospital/nursing home license
 - List of empanelled doctors with their CVs
- 2. Financial Quotation**
 - Cost per health camp, inclusive of professional fees, medicines, consumables, and logistical expenses
- 3. Availability**
 - Confirmation of availability during the proposed quarterly health camp schedule
- 4. Relevant Experience**
 - Details of prior experience in conducting health camps or community/public health projects
